Introduction

Healthwatch Warrington runs an initiative known as 'Virtual Voices' which enables local residents to have their voices heard and win vouchers to be used at local businesses.

Each month Virtual Voices ask its members and the Warrington public, their views on various subjects. In August 2022 we worked with the Warrington Public Health team in charge of the development of the new Health and Wellbeing Survey that will be distributed throughout Warrington in order to improve the health and wellbeing of people in Warrington.

The purpose of this Virtual voices poll was to hear the views of Warrington residents who are OK with the public health team collecting information to conduct the wellbeing survey.

Methodology

The survey was sent to our Virtual Voices mailing list of over **300** members, as well as being widely shared across our social media platforms and shared by Warrington Borough Councils' social media.

The posts had a reach of **4,747** in total across Facebook. Twitter and Instagram and **48** engagements.

There were 113 responses to the survey.





Findings


Age range of respondents

The Health Research Authority defines names and addresses of individuals, taken from the patient register, as 'confidential patient information'. Although, of course, residents who are sent a survey can choose not to complete it, we won't be able to ask residents in advance if they consent to our accessing and using their names and addresses to invite their participation. In your view, is our use of the patient register for this purpose reasonable?
